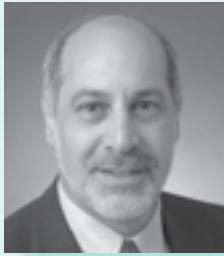
## Visitor Entrance Honors Marshall and Dorothy Reisman

Through the late 1950's, private homes lined Irving Avenue, including the stretch where Crouse Hospital's Irving Unit sits today. One of those houses, at 732 Irving Avenue, belonged to the Gilbert Family, and it was there in the 1930's that young Dorothy Gilbert first met her husband-to-be, Marshall M. Reisman. They married, raised a family, and became very involved in our community. In 1981, Marshall joined the Board of Trustees of the Crouse Health Foundation, a position he held until his death in early 2009. And together, for close to 30 years, both Dorothy and Marshall were strong supporters of Crouse, giving their time and resources to further a wide range of initiatives at the hospital.

Selected family and Crouse archival photographs show Syracuse Memorial and Crouse-

Irving Hospitals next to and across the street from the Gilbert home. These were the only reminders of its presence on Irving Avenue until May 1, 2010, when new signage was installed over the Irving Avenue entrance to Crouse Hospital, officially designating it the Dorothy and Marshall M. Reisman Visitor Entrance. Underwritten by a donation from the Dorothy and Marshall M. Reisman Foundation, the entrance is in approximately the same location as the house, marking a very important spot for the family and Crouse. "We are honored to have the Reisman name so visibly tied to our organization" said Paul Kronenberg, MD, President and CEO of Crouse Hospital. "The sign over the visitor entrance is a tribute to both the Gilbert and Reisman families as well as a tangible reminder of their close ties to Crouse and its campus."

Crouse Hospital recently submitted an application for the Malcolm Baldrige Quality Award, the most prestigious quality

award a U.S. organization or company can receive. A team of hospital managers worked for many months on the submission and it has been a wonderful learning experience. Through this process, we have identified and documented areas where we excel, as well as areas where we need to improve.

For us though, it's not about

winning an award; in fact it is rare for a company to receive Baldrige recognition the first time out. Rather, this exercise has helped further define who we are as an organization. With our mission, vision and values as a foundation, we continue to focus our energies on maintaining and building on the successes we've achieved over these past several years.

This includes working to increase efficiencies throughout the hospital, reducing expenses where we can, growing patient volumes and creating opportunities to enhance physician partnerships. We're making solid progress on these fronts: our medicine and surgical length of stay is below national benchmarks (and the lowest of the Syracuse hospitals) and concerted teamwork in

the area of supply utilization has resulted in more than \$800,000 in savings through the first half of this year. In addition, we continue to attract quality physicians to our hospital, including nationally recognized urologic surgeon David Albala, MD, who in three short months has established himself as the regional expert in minimally invasive robotic surgery using Crouse's da Vinci technology.

We also continue to focus on quality outcomes for our patients. As healthcare reform takes hold on a national level, it will be critical to reduce complications as well as

re-admissions to the hospital. Crouse is well positioned in this regard with a number of

innovative initiatives, ranging

from reducing surgical complications and central line infections in hospitalized patients, to providing post-discharge home visits to congestive heart failure and COPD patients. These are all programs that reflect our commitment to performance excellence across the organization.

Moving forward — and with your continued support — we will remain focused on doing the right thing for our patients, physicians, employees and our community. Enjoy the rest of the summer — and we'll keep you posted on Baldrige.

In addition to perpetuating the special connection that Dorothy and Marshall had to Crouse, the contribution from the Reisman Foundation is helping to support current construction at the hospital. The area around the Reisman Visitor Entrance and the lobby inside were renovated as part of a \$50 million initiative to create the Chris J. and Marshia K. Witting Surgical Center. While the project has touched several areas of the campus, the centerpiece is the construction of a 90,000 square foot addition to house new inpatient operating rooms and future expansion space. The majority of the facility will open in November of this year, with completion of the entire project in September 2011.

The Crouse Health Foundation has mounted a \$6.5 million capital campaign to support the Witting Surgical Center construction, and the Reisman Foundation gift brings total monies raised to-date close to \$5 million. And other current contributions from the Reisman Family are advancing the work of Crouse Hospital too. Carrying on the family's personal involvement are Reisman daughters Sue and Pam. Both are members of the Crouse Hospital Auxiliary and Sue is active on its Board of Directors, currently serving as its Treasurer. Pam and her dog, Chi, are active as volunteers in our Pet Therapy Program, bringing friendship and special moments to patients at Crouse.

## 12th annual SADA Charity Preview Benefits KFMC

The Syracuse Auto Dealers Association (SADA) Charity Preview, an annual event held in conjunction with the association's auto show, raises funds to benefit the children and families of Central New York. Over \$1.5 million has been raised for local charities during twelve SADA Charity Previews.

Crouse Health Foundation was selected to once again be a beneficiary of the SADA Charity Preview held on Wednesday, Feb. 10, 2010 at the Oncenter Complex. As guests mingled among the newest vehicles, they were treated to great food, drinks and musical entertainment throughout the Oncenter Complex. Held the night before the Auto Show opens to the public, attendees leisurely viewed all the latest models local auto dealers had to offer amid a festive atmosphere.

Net proceeds of \$12,650 from Crouse ticket sales were used to purchase an ECLS Fluid Warmer for the Crouse Hospital's Kienzle Family Maternity Center. ECLS, a life-saving process, places the sickest of near-term infants on long-term modified heart lung bypass. During this procedure, the infant's blood is removed from his/her body and circulated through a large circuit and an artificial lung that provides oxygen and removes carbon dioxide. Because the blood is exposed to room temperatures and can become cold, the ECLS Fluid Warmer is used to reheat the oxygenated blood before it is returned to the infant, so that the infant's temperature is not compromised.

## Endowment Fund Awards \$800,000 Toward Hospital Equipment and Patient Care Services

The Crouse Health Foundation's Endowment Allocation Committee recently made its annual distribution of investment income in support of Crouse Hospital programs and health initiatives and the enhancement of its facilities and equipment. According to Carrie Berse, president of the Foundation, the Foundation Board of Trustees this year allocated \$800,000 in investment income earned by the endowment fund in 2009. "Although market conditions continued to be challenging last year, a diversified portfolio and an investment philosophy that is long-term in nature allowed the Foundation to make a significant disbursement to Crouse Hospital for 2010."

The Crouse Health Foundation Endowment Fund was established in 1983 through a \$5 million community fund-drive, and today has a market value of more than \$19 million. The principal of the fund remains untouched, while a portion of the investment income earned annually is given to Crouse Hospital. Investment income disbursements began in 1988, and monies awarded in support of the hospital to date total more than \$15.2 million.

The endowment this year funded 40 projects, including \$28,500 for scholarships for the Crouse Hospital School of Nursing and:

- Almost \$343,000 for enhancements to Surgical Services, in anticipation of the opening of the hospital's new Witting Surgical Center, including the largest allocation going toward the purchase of the Valleylab Force FX Electrosurgical Unit, which provides a smooth incision through all tissue types, adjusting automatically to changes in tissue density to minimize the risk of tissue damage;
- Ten projects, totaling close to \$99,000, for Women's and Children's Services, including technical enhancements to improve patient care for our tiniest patients in the Baker Regional Neonatal Intensive Care Unit and OB patients in the Kienzle Family Maternity Center;
- \$62,000 towards an information technology system that will allow physicians and their staff the ability to review patient information securely from their offices; and
- \$95,795 to the Medical Imaging department for a system that produces digital whole body x-rays used in treatment planning for scoliosis surgery.

# Tribute Evening – Friday, October 29

The Physicians of Neonatal Associates of CNY will be recognized as this year's Crouse Health Foundation's Tribute Evening honorees. Drs. Steven Gross, Ellen Bifano, Thomas Curran, Bonnie Marr, Michelle Bode, Beverly Roy, and Boura BouAram play an integral role in the achievements of Crouse Hospital. Their success story will be shared at Tribute Evening 2010 on Friday, October 29 at the Nicholas J. Pirro Convention Center, Oncenter.

Tribute Evening 2010 will feature an extended reception, gourmet dinner, tribute presentation, and entertainment by MARY WILSON of the Supremes. The highlight of the evening will be the salute to the Physicians of Neonatal Associates of CNY.

Crouse Hospital (and its predecessors) has been taking care of premature infants since 1944. Dr. Margaret Williams pioneered neonatal care as we know it today by serving as the director of the Neonatal Intensive Care Unit (22 bassinets) created in 1974. Under her leadership, Crouse became one of the nation's first Regional Perinatal Centers (NYS Level III) in 1975 through a \$2.2 million Robert Wood Johnson Foundation grant. By 1980, the regional infant mortality rate had dropped 40%. Dr. Steven Gross became the Director of the NICU in 1985.



In 1994, Neonatal Associates was formed becoming the exclusive provider of Neonatal Services at Crouse Hospital. With the opening of the Kienzle Family Maternity Center in 1999, an expanded NICU (51 bassinets) was opened and the name was changed to the Walter R. G. Baker Regional Neonatal Intensive Care Unit. The nurseries were named for Dr. Margaret Williams. In 2003, Crouse Hospital's NICU was upgraded to a NYS Level IV facility.

Currently, Crouse Hospital is licensed at 57 bassinets and cares for babies born as young as 24 weeks gestation and weighing just 500 grams. The neonatologists provide coverage 24/7, 365 days per year caring for 800-1,000 infants annually. Since 1985, over 21,000 babies have been patients in Crouse's NICU. As the Regional Perinatal Center, Crouse serves 19 birthing affiliates in 15 counties providing transport services to our NICU. The Physicians of Neonatal Associates have teaching appointments in Pediatrics at SUNY Upstate Medical University and are national research leaders. They are actively involved with the Ronald McDonald House, March of Dimes, and other related organizations.

MARY WILSON promises to bring the same passion as she did singing with the original Supremes. Mary's lively performance will feature some of the Supremes' 12 No. 1 hits from the 60's including the ever popular "Baby Love."

Tribute Evening 2010 proceeds will be used to support the work of the Baker Regional Neonatal Intensive Care Unit at Crouse Hospital and other activities of the Crouse Health Foundation including purchasing special equipment, underwriting new initiatives, and funding educational programs and scholarships.
