COVID-19 PLEDGE

Pomeroy College of Nursing at Crouse Hospital (PCON) is an academic community committed to maintaining an atmosphere of safety and respect that is conducive to both the personal and academic growth and development of each student. Every PCON community member is expected to uphold a high standard of civility and is responsible for helping to ensure a safe and healthy campus environment.

As a member of the PCON community, I am committed to doing my part to help limit the spread of COVID-19 by making my own health and safety and that of others a top priority. I pledge to act with purposeful care and take the following actions:

- Monitor my own health on a daily basis for symptoms of COVID-19 and notify both my primary healthcare provider and College Administration should I exhibit symptoms
- Stay home when I am feeling sick or exhibiting COVID-19-like symptoms and avoid close contact with people who are sick
- Participate in regular, routine COVID-19 screening upon entry into any College/Crouse Health building
- Regularly check my “crousecon” email for College correspondence related to COVID-19 and immediately follow any protocols or new directives therein
- Participate fully and honestly in any contact tracing program as requested by health officials
- Practice good personal hygiene consistent with public health protocols, such as frequent handwashing for at least 20 seconds, use of hand sanitizers when entering and exiting shared spaces and wiping down high-touch surfaces after use
- Abide by College, Crouse Health and County Health Department guidance and directives for isolation or quarantine
- Adhere to space capacity limits and maintain at least six (6) feet of social distance from others
- Follow all protocols established for shared campus spaces, including hygiene, social distancing and acceptable use
- Always wear a Crouse Health approved face covering in any space on campus including while outside travelling to and from buildings
- Never share any food, beverages, utensils, water bottles or other personal items with others
- Avoid traveling outside of Central New York for the duration of the fall 2020 semester. If I must travel during this period, I will notify College Administration and follow any directives related to my return to coursework following my travel
- Refrain from inviting any family, friends or guests to campus
- Take extra precautions when I am off-campus such as avoiding large group events and adhering to local COVID-19 directives established to limit exposure and community spread
- Ask questions of College Administration when I require clarification about any COVID-19 protocol, procedure or directive

I understand that I must adopt behaviors that advance our collective ability to reduce transmission of COVID-19. I commit to doing my part and meeting my obligations to the College community. I realize that the safety of our community is a shared responsibility and my actions can put myself and others at risk. I acknowledge that failure to comply with any COVID-19 protocol, procedure or directive may result in a violation of the Code of Student Conduct resulting in potential sanctions.
