The plan has contracts with SYMETRA LIFE INSURANCE COMPANY, NEW YORK LIFE GROUP INSURANCE COMPANY OF NY, and CIGNA LIFE INSURANCE COMPANY OF NEW YORK to pay Life Insurance, Short-term Disability, Long-term Disability, and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$604,798.
